AWS Board Minutes November 21, 2019

Members Present: Patty Bird, Gary Caldwell, Jerry Fabiano, Merrie Krisl, Gail Mardfin, Patricia Marina, Deni Marrone, Carol Mills and Fran Nielsen.

Meeting was called to order at 10:35 a.m. by President, Carol Mills.

President: Carol said that Trula LaCalle had sent the board a letter requesting she sell her book (a novel, *Helen's Crusade*) at the Holiday Party with 20% of proceeds going to the club. Fran said there was some precedence for this. We agreed that members, upon submitting a letter to the board, could sell personally-created works of art at our meetings with 20% going to AWS.

Carol said she needed a person to circulate and sell raffle tickets for the small paintings during the Holiday Party. (Carol Leif volunteered at the member meeting.) Deni Marrone volunteered to do the auction. (Jan Blake volunteered to assist her at the member meeting.) Members need to take home any auction items that do not sell.

We have not heard yet about our county grant application. We still need dry space (40-50 sq. ft.) for our panels.

Vice President: Jerry noted that he had a great response (57 artists) from everyone regarding possible demonstrators. In January, Susan Bradford will demonstrate a method of using three colors plus white to paint cohesive works. Jerry is concentrating on having demos which teach the membership things they might want to learn. John Burns, a pastelist, will demo in July.

Treasurer: Patty reported she has received a nice thank you from the Analy Art Department. They intend to use our gift to buy good-quality brushes for the students. She will ask for an invitation to their student art show. We have a balance of \$3037.07. Need to pay about \$1200 in rent, but we are looking good.

Apple Blossom Show: Patricia Marina has emailed all chairs from last year. She asked Carol to request signups for all vacant chairs at the membership meeting.

Corresponding Secretary: Carol asked we send cards to people who used to be active, but whom we have not seen recently. Gail suggested we might do the same for people who have joined, attended a few meetings, and then have been absent. Please let Fran know if you know of anyone who might appreciate hearing from us.

Membership: Carol noted that Ann Nichols is on the roster, but has passed away. Gail suggested Gary change the column title about dues to read "Dues paid for 2020," because there was some confusion over who paid. Gary will send a blind email to remind those who have not paid yet.

Website: Deadline for updating your artwork on our website is December 20th. 3 pieces, same format.



Venues: Deni asked if we are open to venues that only show on occasion, as opposed to year round. Yes.

Roster: Merrie will ask members to update info for the roster, which will come out in February

The meeting was adjourned at 11:45 a.m.


11/20/19 Artist Talk: COMPOSITION with Gail Mardfin



Speaking in the first person, I was very pleased with the way my "lecture" on Composition was received at the November meeting.
Afterwards, I received many, many thanks; I heard from people that I

know are very art literate and I heard from one who said, "I never had any formal art training, so this was all helpful to me." Just what I was hoping for.

Although I attended two colleges and a master's program to become an art teacher, I honestly don't remember being taught any basics of composition – it was the 70s and we were encouraged to "do our own thing!" I know I was never taught how to draw in perspective! But I learned a lot "on the job" while



teaching art in a girls' boarding school in New Jersey for 20 years. I developed my own Basic Rules of Composition that I presented in the introductory art class, which everyone was required to take.

These I shared with my AWS audience: Place your focal point where it is NOT already a "natural" focal point (i.e. not center, corners, or half-way points on edges - see illustration above, where the red dots indicate "good" places for a focal point). Make use of edges and corners in a way that reroutes one's attention back to the entire painting. Keep a piece "balanced," often in an asymmetrical way. Even

expanses of seemingly unused space can work to create such balance.

I then solicited other compositional "rules" that members had learned. The Rule of Thirds is a good one for dividing space in a pleasing way. Variety in placement, size, shape, and color is recommended, as well as the use of repetition and pattern to help move one's eye around a composition. Identifying the dominant horizontal and vertical are very useful in strengthening a composition, explained Beverly Bird.

My presentation included 50+ slides of representational and abstract art works, both famous and not so, which we analyzed as to focal point and

how each artist led the viewer's eye around the format. I also stressed that rules of composition were made to be broken and used a number of famous artists' works to demonstrate that. I am also grateful to my personal art friends whose works I included. I love





I learned the basics of Powerpoint for this presentation, encouraged by Phil Wilkinson, who loaned AWS the projection equipment owned by Oakmont Art Association, of which he is the president. Thank you, Phil! I spent many hours preparing for the presentation and used the full hour and a half of allotted time, but it was a lot of fun being in the Art Teacher role again, especially with so many eager "students" willingly participating in the class discussion!

Fire Stories...



I trust all who are reading this were safe and sound during and after the most recent Kincaid Fire in Sonoma County. Stories abound.

Karen Miller has a recent story of fire to tell: Wednesday the fire started. Thursday a couple from Virginia bought her "Ridge to the East" (shown at left) and "Manzanita" pastels at Upstairs Art Gallery in Healdsburg. On Friday she shipped both paintings. Saturday they were evacuated. The following Wednesday they returned and Karen took a photo of the same scene after the fire had raged (shown at left, below). With confirmation that her pastels had been safely delivered, she sent the post-burn photo with the following explanation to her patrons:

...lots to deal with here in Healdsburg right now! We were evacuated



to escape the Kincade Fire (still going but our town is safe now). Your paintings got out in the nick of time. Mailed out on Friday, this area burned on Saturday night (I think). On my way back yesterday I stopped by the place where I sat painting "Ridge to the East" and took a photo. I thought you might like to see it:

The darker hillside on the right is the burned area. Sorry for the poor photo

quality, I took it through the car window as there is still smoke in the air. Hope you are well and that you enjoyed your visit to Healdsburg. You now have a disaster story to go with your paintings!....



During the October members' critique, **Jerry Fabiano** shared a study he was working on, part of a triptych to be gifted to a friend who had lost their home in the 2017 fires. The completed housewarming gift is now finished! (shown at left)



A third "fire story": At the 2018 Gravenstein Fair, **Carol Mills** sold an original Round Barn watercolor (a "fall" version") to someone who had grown up near to the landmark (shown at left). She then painted a "summer" version of the Round Barn. Both the original summer watercolor and a print of the fall one were hanging at the Airport Health Club. She recently received a call from a man that works at the company on the top of Fountaingrove Parkway (formerly H.P., now something else). He said a friend he worked with up there is retiring and he wanted to buy the original Round Barn painting for him, as they had both driven by it to and from work for many years - until it burned down in 2017. He also bought the fall print for himself!


Just three examples of how AWS artists and their artwork recorded prefire history and contributed to a beautiful post-fire future.



Written by the excellent Canadian landscape painter Robert Genn (now deceased) and his artist-daughter, Sara, the letters are encouraging, humorous, philosophical, and helpful! Here's a favorite quote I shared during my presentation on Composition. xo gail

"Compositional mastery is a variety of traditional rules that beg to be broken. That's why composition is the gueen of the skills. With composition you learn to control and play with the eye and move it within the picture plane. Composition includes the golden mean, the rule of thirds, big and small, dark and light, activation, circulation, focus, pattern, stoppage and a pile of other ploys, many of them developed by you and unique to yourself. Compositional mastery also means the avoidance of lineups, homeostasis, and a jungle road of potholes too tedious to include here. Learn to compose intelligently in your own vocabulary and you can get away with murder. Compositional mastery takes time and patience." - Robert Genn, 2012
