"Nice to see people without a mask!" said President **Carol Mills.** And welcome to AWS' newest member, Beverly Kjeldsen (prounced Kelson).

WE MISSED THE REST OF YOU!

<u>Turns out the majority of us ARE DOING ART!</u> A number of people shared their latest creations, many of which are featured elsewhere in this newsletter.

Christine McNamara finds the Facebook LIVE collage site led by Crystal Marie Neubauer to be very inspirational. The page is "Crystal Marie: Canary Rising" – it's a "private group" with 1.5K members, so log on! Every day at 8:30 AM, "It gets my engine started artistically," says Chris, who describes Crystal as a very inspirational person and helpful in getting people out of their ruts and overcoming their fears.

Georgia Simons reported she had once again begun a 30 Day Strada Challenge, where she paints still lifes in oil, mostly flowers and fruit in a 9x12 format, doing about two hours of painting from life. More on page 8.

After an ergonomic stretch, **Jerry Fabiano** started the video discussion by reminding people that he is choosing videos based on what subjects the members told him interested them. He wants to have the prompts correlate with the videos, so our next prompt will follow August's video and will be "figures in the environment" (any kind of scene). He asked how many of the Zoom attendees had tried a seascape and almost everyone had. He felt the presenter was a good teacher and noted we are blessed to have the Pacific Ocean so close. **Beverly Kjeldsen** said she was up in Fort Bragg at the moment, providing lots of ocean inspiration.

Jerry liked the practical way the artist starts from the top and works down and from the distance working forward. Light coming from behind the waves works best and the lightest lights are added last. Jerry suggested trying the app Waterlogue, which allows you to take your photos and enhance them to look like watercolors. It informs your color and value choices.

Carol Mills feels that waves are hard to do in watercolor, reserving the whites, although she says she does sometimes uses white acrylic for highlights. She loved the way he used a fan brush to paint the foam under the waves.

Christine McNamara liked the shadows he painted under the waves. She recommended the book, "Paint the Sea and Shorelines" by E. John Robinson. It is out of print, but you can find copies online from sites like Abebooks.com.

Patty Bird asked about his use of the dagger brush. It's a long flat, angled to a point, allowing very fine lines. [AT RIGHT] She liked that he used a "hacked up" fan brush, which he tapped to paint droplets above the waves. She noted she has done a seascape from a photograph and felt it was successful.

Georgia Simons was impressed with the sketching he did before painting. She usually avoids it, but he made it look like fun! He then had a good value plan from which to paint.

On other topics, Patty suggested we all look for covered places where we might do plein air painting through the winter. Jerry said that Howarth and Ragle Parks both have gazebos.



A Time for Questioning






