Member Profile with Carol Mills

Watercolor and Pastel Artist

Question: So Carol, where were you born and raised?

Carol: Los Angeles, but I mostly grew up in Compton, Southeast of L.A.

Q: Did you have siblings?

C: Yes, I was the second of four girls.

Q: As a child, were you interested in art?

C: I loved making crafts of all kinds. I recall when I was about ten years old I made a guitar our of a cigar box.

Comment by Paula: Wow Carol, that is impressive!

Q: Carol, did you have other interests?

C: Yes, I loved music and sang in the choir all through my Catholic school elementary years. When I got to high school I more interest in drama.

Q: Was there anyone in your immediate family who artistically inspired you?

C: Yes, my older sister was a very accomplished fine artist in oil. My parents' home was filled with her paintings and I still have many myself. She was four years older than me and we did live together when I was in college.

Q: Carol, do you recall taking any art classes in college?

C: Yes, I had to take several art classes required for earning my elementary teaching credential.

Q: What was that like?

C: That was mostly an introduction to different kinds of art projects that could be used in the classroom We had to create samples of various types of ar projects and the methods and supplies types of art projects and the methods and supplies used in each. then al of that information was store in a file as a teaching resource. Those really came in handy for my whole teaching career. In fact, I kept them for my own kids and still use them when I have my grandkids over.

Q: What brought you and your husband to Sonoma County?

C: We had friends in Marin County that we visited over time. We loved Sonoma County. My husband wanted to get of L.A. and desired to find a vine-yard. Shortly, we brought an 80 acre vineyard in Forestville .That is when we moved up here. We had two young daughters and this started our new life.

Q: How was it that you got involved in fine art and painting?

C: It was my desire to see that my husband engaged in art because he was the real talented one. His mother was an excellent watercolorist. I was the motivated one to find art classes that we both could enjoy together, and that is how it happened.

Q: Did you both stay interested?

C: I did, but my husband preferred his more active hobbies like skiing, surfing and biking. It was about ten years ago I started taking watercolor classes from Berenice Iriks. I also took pastel from Judy Butler through SRJC.

Q: Do you still own your vineyard?

C: We had the vineyard for 38 years, plus we built a winery in Sebastopol. We sold the business three years ago. Q: Did you make your career form your winery business?

C: No, I started volunteering in politics in the early 80's for local county races. Then I become a paid political campaign manager. Then I eventually started working for Ernie Carpenter in 1982, who was the West County supervisor for 14 years. Then I was the campaign chair and worked for 12 years as Mike Reilly's Administraive Assistant, then I retired.

Q: Then what id you do?

C: Since we lived in Forestville and my daughters went to school there, I was active on the Forestville School Board, West County Community Services and helped out with our family winery business.

Comment by Paula: Carol, I would say you've had a very full life!

Q: Now days, are you volunteering in any other pubic service?

C: Yes, about once or twice a month I volunteer as an arts and crafts teacher for the Los Guillicos Juvenile Justice Center and have done this for ten years.

Q: What is that like?

C: They have extreme security policies and they screen all my supplies and craft tools. Even the scissors have to be plastic. I typically work with the girls unit but on occasion I have a few of the youngest boys, but deal with them at a different time.

Q: Can you describe a recent fun activity they enjoyed?

C: Yes, the girls really enjoyed making masks. The kind like the Lone Ranger wore that covers the eyes. I provided all the supplies and they really got into it. It was very satisfying to see them lose themselves for a short time as they were very busy in this creative process.

Q: What time of year is your favorite to work with the residences?

C: Christmas time is best of all. Over time, this season's celebrations and traditions have grown to include gifts for each resident and up to three gifts each. All the different departments within the facility participate in a tree decoration contest and it doesn't stop there. They go all our and make decorations with streamers and lights

twinkling all around. This really brings to life the holiday spirit to those that need it most.

Q: How did you find out about AWS?

C: My Thursday art group suggested I join and I am glad I did.

Comment by Paula: Carol, I am in such awe of your generous pubic service you have offered over your lifetime. I bet you take that art project file system with you to the Juvenile Justice facility making good use of those creative ideas. I am honored to be witness to your life and how your artwork and crafts have brought so much joy to your family and others, especially those that are so much less fortunate. I so enjoyed coming to your lovely home in Forestville and getting to know you at a depth unforeseen before our interview. Thank you so much Carol.

Meeting was called to order at 10:49 by President, Carol Mills.

President: Need Publicity Chairperson(s)! The Chamber has requested info about our ABF art show from last year. They need pictures, etc. Bob will work on it. Carol has been working with Elizabeth from SCA to get our meetings listed in their online newsletter and that is going well. James will continue to update the website. Discussed nominating committee. Most board members are returning except someone for publicity. Gail Mardfin will take over the newsletter from Lorraine in January. We do need to list the current nominees and take other nominations from the group in October. Those will be voted on at the November meeting and installed in December. Carol will check on whether Beverly Bird wants to continue as the historian and also on the hospitality volunteers. Need a committee to do the Christmas party. Discussed other venues such as the Harvey Mendelson gallery near the 6th Street Playhouse in Santa Rosa. Carol to get more information from him.

<u>Treasurer</u>: Current balance is \$3660.96. Patty reported that our income from the Gravestein Fair was \$5,108.91 and our expenses, plus paying the artists their percentage, were \$5,006.29. While we only netted \$102.62, we always gain valuable promotion with the community for our organization. We made \$183 from last month's book sale.

Discussed Jacque's bequest and it was voted to pay \$500 for Best of Show, \$300 for the Founders Award, and \$100 each for the first place winners of out 6 art categories, plus the Popular Vote Award. This totals \$1500 each year.

<u>Vice President:</u> James will give a talk on framing in October. November will be Deni Marrone demonstrating her method of pouring acrylics.

Membership: Merrie and her husband, Eric, will do a membership booklet to be produced in January. Gary said he has been tracking those eligible for the Apple Blossom Art show and prior to the September meeting, 11 qualified. Dues are due next month and everyone who want to must qualify for the show by the end of the year. Check the roses for your stats!

Ken Berman Demo - September 20, 2018

Ken Berman was an architect before turning to painting. A self-taught painter, he used The Artists Handbook to learn about art, and the painting process. Known for the mechanical forms in his abstract work, previously black/white/grey, Ken has added color to the mix. His demo presented a systematic overview of his painting process:

- The properties of oil colors; supports; canvas; panels; metals; solvents. He uses Gamsol; mediums and varnishes (his preferred glaze: 1 damar, 3 liquin, 5 mineral spirits);
- 2. Building Foundations he uses a variety of tools: brayers, brushes, rags, knives; creates an impasto layer use Underpainting White (Windsor-Newton); choses base color, considering effects of future color applications.
- 3. Glazing: in his unique approach he applies glazes and then paints into them; not using a palette he applies color to the brush from the opening of the tube. Gamlin is his preferred paint brand as it has less pigment, thus better for glazing.

His painting precess in intuitive. He stars with no specific design, continually in tune to the evolving flow as he add color, shapes, lines with a myriad to tools to create a strong visual statement.
